This Inspector attended this workplace with respect to a worker injury reported to the Ontario Ministry of Labour, Immigration, Training and Skills Development (MLITSD) Call Centre and to determine compliance with the requirements of the Occupational Health and Safety Act/ 90 (OHS/90) and related legislation.
